Overview:

The report, dated January 27, 2025, was prepared by Katherine F. Weber from Inslee, Best, Doezie & Ryder for the University of Washington, Paul G. Allen School of Computer Science & Engineering. It was initiated to investigate workplace concerns within the Systems Lab (SysLab) related to allegations of sexism, misogyny, gender harassment, and inappropriate conduct.

Scope of Investigation:

- The investigation was initiated after the "Women of SysLab" sent an undated letter (around July 12, 2024) to the SysLab Faculty outlining various concerns, including:
 - Inappropriate romantic gestures.
 - Aggressive and intimidating behavior by a male postdoc towards a female student.
 - Harmful, sexist comments from another male student.
 - General references to gender harassment, sexism, and a "background noise of misogyny."
 - Dissatisfaction with the response from certain faculty members.
- The women also provided a detailed timeline of events spanning back to 2022.
- A formal complaint was also made by one of the male students (Mr. Eta) alleging harassment based on gender, religion, national origin, and retaliation.
- A total of 33 participants were interviewed, mostly current or former SysLab student-employees, along with postdocs, faculty, and staff.

Allegations:

- The women's complaints centered around:
 - Sex/gender discrimination and harassment.

- Sexual harassment.
- o General misogyny and sexism, contributing to a hostile work environment.
- Mr. Eta's complaint included:
 - Allegations of discrimination based on gender, religion, national origin, and caste.
 - Retaliation from faculty and female students.

Key Events & Incidents:

1. Background (2022-2023):

- SysLab was described as a collaborative, inclusive environment until the 2023-2024 school year.
- Increased student population (35 total, with 7 female and 28 male) led to a shift in dynamics.

2. 2023-2024 School Year:

Uncomfortable Interactions with Mr. Eta:

- Multiple instances of inappropriate comments and behavior, including sexist jokes, off-putting comments, and insensitive remarks about depression.
- Text messages sent to Ms. Alpha containing sexist and vulgar content (e.g., song lyrics, insensitive jokes).

• February 11, 2024: Kanye West/Taylor Swift Incident:

- Heated argument between Mr. Eta and other students over Kanye West's behavior towards Taylor Swift at the VMAs, leading to Mr. Eta feeling attacked and targeted.
- Follow-up conversations attempted to resolve misunderstandings but escalated tensions.

3. Post-Incident Developments:

- Mr. Eta expressed concerns about his reputation being damaged and felt ostracized.
- Faculty involvement (Prof. Omicron, Prof. Nu, and others) attempted to mediate but often exacerbated issues.
- Advice was given to Mr. Eta to try to clear the air with his peers, but efforts were unsuccessful.

Findings & Conclusions:

Investigation Outcome:

- The investigation found no violations of the University's policies (Executive Order No. 31) or applicable federal and state laws.
- The allegations did not meet the threshold for unlawful harassment or discrimination.

- However, issues were noted regarding:
 - o Poor professionalism.
 - o Lack of equity, inclusion, and belonging within SysLab.
- The report encouraged the School to consider these issues moving forward.
